"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs

Township, designated as Lot No. 12 on plat of Development No. 2,

Green Plant, recorded in the R. M. C. Office for Greenville County
in Plat Book "P", Page 119, and having the following courses and
distances:

BEGINNING at an iron pin on the northeast side of Carolina Avenue, joint corner of Lots Nos. 11 and 12, and runs thence with said Avenue, N. 54-39 W. 85 feet to an iron pin; thence N. 56-31 W. 46.5 feet to an iron pin; thence N. 33-29 E. 189.1 feet to an iron pin on alley; thence with alley, S. 54-41 E. 138.1 feet to an iron pin; thence S. 35-21 W. 187.6 feet to the beginning.
