All that piece, parcel or lot of land on the northern side of Belvue Road in the County of Greenville, State of South Carolina, and being known and designated as Lot No. 7 and the western portion of Lot No. 6 on a plat of property of Ora Greene Kelley, recorded in the office of the Clerk of Court for Greenville, County, South Carolina, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Belvue Road at the joint front corner of Lot No. 7 and 8 and running thence along the boundary of said lots No. 28-43 E. 200 feet; thence along the rear boundary of Lot No. 7, S. 61-17 E. 82 feet; thence along the rear of Lot No. 6, S. 77-28 E. 30 feet; thence through Lot No. 6 S. 15-30 W. 1964 feet to a point on Belvue Road; thence along Belvue Road N. 71-34 W. 50 feet; thence continuing along said road N. 64-31 W. 105 feet to the point of BEGINNING.

Any amount or amounts so paid out shall become a part of the debt secured hereby, shall become immediately due and payable and shall bear interest at the highest legal rate from the date paid.
