NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be included to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagoe at and well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and automs.

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville in the Woodslide Mills Village in the Town of Simpsonville, and being More particularly described as lot No. 80 as shown on a plat entitlod "A Subdivision of Woodside Mills, Simpsonville, S. C." made by Pledmont Engineering Service, Greenville, S. C. February 1953 and recorded in the R. M. C. Office for Greenville County in Plat Book GG at page 5. According to said plat, the within lot is also known as No. 16, First Street, and fronts thereon 80 fEEt, and being the same lot conveyed to Herace L. Mahaffey and Mamie Lou C. Mahaffey by deed from Woodside Mills Receded in Deed Book 475 at page 479 in the Greenville County R. M. C. Office and By deed From Horace L. Mahaffey conveying his 1/2 interest to Mortgagor by deed recorded in Deed Book 823 at page 358 in the Greenville County R. M. C. Office.

Together with all and singular rights, members, herditaments, and appurtenences to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had thereform, and including all heating, plumbing, and lighting fitting now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully soized of the premises, hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all lions and encumbrances except as provided herein. The Mortgagor further covenants to varrant and forever defend all and singular the said premises unto the Mortgagor forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
