C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Highland Township, lying on the West side of the Old Greenville Road, bounded by lands now or formerly of Homer Fowler, Fred Sudduth, Harold B. Howard, and possibly others, containing 5.50 acres, more or less, and having the following courses and distances:
