"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of

Greenville, Butler Township, within the corporate limits of the City of Greenville, and being known and designated as lot #2 of the property of W. T. Patrick and W. R.
