All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, within the correporate limits of the Town of Mauldin, being known and designated as Lot 72 of a subdivision known as Glendale II, plat of which is of record in the R. M. C. Office for Greenville County in Plat Book OOO at Page 55 and having the following metes and bounds, to-wit:
