- (7) That the Mortgagor shall hold and enloy the premises above conveyed until there is a default under this mortgage &r in the note secured hereby. It is the true meaning of this instrument that if the Mortgagor shall fully perform all the terms, conditions, and covered and order of the note secured hereby, that then this mortgage shall be utterly null and void; otherwise to remain in full
- (8) That the covenents herein contained shall bind, and the benefits and advantages shall inute to, the respective hairs, executors, administrators, successors and assigns, of the parties harets. Whenever used, the singular shall included the plural, the plural the singular, and the use of any gender shall be applicable to all genders.
