ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, to wit: GANTT TOWNSHIP, ON THE WESTERN SIDE OF OLD GROVE ROAD AND BEING KNOWN AND DESIGNATED AS THE EASTERN END OF LOT No. 4 according to a plat of the Property of John A. Carson Made by J. Coke SMITH, SURVEYOR DATED FEBRUARY 1946 AND HAVING, ACCORDING TO SAID PLAT, THE FOLLOWING METES AND BOUNDS, TO-WIT:

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.
