"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Kensington Road, being shown and designated as Lot 39 on plat of Brook Glenn Gardens recorded in Plat Book JJJ at page 85 in the R.M.C. Office for Greenville County and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the eastern side of Kensington Road at the joint front corner of Lot 38 and running thence with the line of Lot 38 S. 69-04 E. 150.2 feet to an iron pin; thence N. 22-50 E. 31.8 feet to an iron pin; thence S. 73-23 E. 13.5 feet to an iron pin; thence N. 17-11 E. 79.1 feet to an iron pin at the rear corner of Lot 40; thence with the line of Lot 40, N. 69-38 W. 162 feet to an iron pin on the eastern side of Kensington Road; thence with the eastern side of said road, S. 19-30 W. 110 feet to the beginning corner.
