All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, on the northern side of Long Forest Drive, being shown as the major portion of Lot No. 13 on plat of Property of Nabors and Bridges recorded in Plat Book O at page 195 and having according to said plat the following metes and bounds, to-wit:
