"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township, containing approximately 2.6 acres, being bounded on the Northeast by the Southwest right-of-way line of U. S. Highway I-385; on the Southwest side by lands of Elizabeth Drummond and lands of Mildred P. Woods, et al; on the Northwest by lands now or formerly of George Redmond; and on the Southeast side in part by the Congaree Road (sometimes called Roper Mountain Road), being in dimension approximately 125 feet x 1170 feet x 75 feet x 1167.3 feet.
