All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Dexter Drive and being known and designated as Lot No. 40 on plat of Drexel Terrace, dated April 1, 1961, prepared by Piedmont Engineering Service and recorded in the RMC Office for Greenville County in Plat Book QQ, Page 177, and having according to said plat the following metes and bounds, to wit:

Beginning at a point on the eastern side of Dexter Drive, joint front corner of Lots 39 and 40 and running thence N 11-37 W 115.0 feet with Dexter Drive to the joint front corner of Lots 40 and 41; thence turning and running with the joint line of Lots 40 and 41 N 80 E 175 feet to a point at the joint rear corner of Lots 40 and 41; thence turning and running with the joint line of Lot 40 and Lots 62 and 63 S 14-05 E 105.6 feet to a point at the joint rear corners of Lots 39 and 40; thence turning and running with the joint line of Lots 39 and 40 S 76-54 W 179.3 feet to the point of beginning.
