All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northwest side of High Hill Street, being known and designated as Lot No. 53, Augusta Road Hills, according to plat of said subdivision prepared by Dalton & Neves in December 1940 as recorded in the R. M. C. Office, County of Greenville, S. C. in Plat Book M, on page 33, and having the following metes and bounds, to-wit:
