All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 26 of a subdivision known as Extension of Section One of Brookwood Forest according to a plat thereof prepared by C. C. Jones, Engineer, dated February 13, 1963 and recorded in the R. M. C. Office for Greenville County in Plat Book XX, at Page 96, and having, according to said plat, the following metes and bounds, to-wit:
