____(heremalter referred to as Mortgagor) SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of Twenty-One

Thousand One Hundred Fifty and no/100----- (\$21,150.00) Dollars, as evidenced by Mortgagor's promissory note of even date herewith, said note to be repaid with interest at the rate

therein specified in installments of One Hundred Sixty-Three and 26/100 (\$ 163.26). NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

- All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Austin Township, in the Town of Mauldin, lying on the northeastern side of Candlewood Court, being shown and designated as Lot No. 15 on a plat of Hillsborough, Section 1, prepared by Jones Engineering Services, dated April, 1969, recorded in the R.M.C. Office for Greenville County in Plat Book WW, page 56, and having, according to said plat, the following courses and distances, to wit:

BEGINNING at an iron pin on the northeastern side of Candlewood Court, the joint front corner of Lots Nos. 14 and 15 as shown on said plat, and running thence with the common line of said lots N. 68-27 E. 200.4 feet to an iron pin; thence N. 14-22 E. 30.8 feet to an iron pin at the joint rear corner of Lots Nos. 15 and 18; thence with the line of Lot No. 18, N. 44-47 W. 106.9 feet to an iron pin; thence with the common line of Lots Nos. 15, 16 and 17, S. 57-08 W. 260.9 feet to an iron pin on the northeastern side of Candlewood Court; thence with the northeastern side of Candlewood Court, S. 73-30 E. 78 feet and S. 57-06 W. 30.2 feet to an iron pin, the point of beginning.
