"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, about one mile southward from the City of Green, and being shown as Lot No. 27 in Brookhaven, property of IMEXEMBLE the Dobson Estates, and later to William E. southerland and Barbara A. Southerland, according to survey and plat by H.S. Brockman, Registered Surveyer, dated December 12, 1957, amended September 1, 1959, recorded in Plat Book RR, page 41, R.M.C. Office for Greenville County, and having the following courses and distances:
