MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

A. M. Bridges & Sons, Inc., a South Carolina corporation with its principal place of
business in Greenville County, S. C. (hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:
WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of
Eleven Thousand and No/100(\$11,000.00)
Dollars, as evidenced by Mortgagor's promissory note of even date herewith, which note contains a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain
conditions), said note to be repaid with interest as the rate or rates therein specified in installments not as set out in said

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 152 according to a plat known as Addition to Coleman Heights prepared by Piedmont Engineers & Architects dated April 24, 1964, recorded in the R. M. C. Office for Greenville County in Plat Book RR, at Page 161, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Alta Vista Circle, joint front corner of Lots Nos. 151 and 152, and running thence with the joint line of said lots, S. 3-29 W. 190 feet to an iron pin at the corner of Lot No. 157; thence with the line of Lot No. 157, S. 87-25 E. 58.2 feet to an iron pin at the corner of Lot No. 156; thence with the line of Lot No. 156, N. 58-43 E. 131.5 feet to an iron pin at the joint rear corner of Lots Nos. 152 and 153; thence with the joint line of said lots, N. 17-42 W. 157.8 feet to an iron pin on the southern side of Alta Vista Circle, joint front corner of Lots Nos. 152 and 153; thence with the southern side of Alta Vista Circle, S. 70-09 W. 55 feet to an iron pin; thence continuing with the southern side of Alta Vista Circle, S. 82-45 W. 60 feet to the point of beginning; being the same conveyed to the mortgagor corporation by Stanley I. Coleman by deed of even date, to be recorded herewith.

This mortgage is given in connection with a construction loan, and it secures a promissory note which provides, among other things, for monthly interest payments, the principal payable in full on or before 12 months from date, and a provision for an increase in interest rate.
