Simmons, Surveyor, dated August 10, 1963, which plat is recorded in Plat Book YY, Page 153, Greenville County R. M. C. Office, with a frontage on Bent Creek Drive of 100 feet, and on curve to Bowers Circle of 28.3 feet, and running along the northern side of Bowers Circle 140 feet.
