"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, containing 2.4 acres, more or less, as shown by plat of Jones Engineering Service, dated June 15, 1967, which plat was to be recorded in the R.M.C. Office for Greenville County, South Carolina, and according to said plat, having the following metes and bounds, to-wit:

BEGINNING at an iron pin in an access road at a point 465 feet from Raymond D. Smith's corner and running thence N. 38-40 W. 235 feet to an iron pin in said road; thence S. 51-20 W. 445 feet to an iron pin; thence S. 38-40 E. 235 feet to an iron pin; thence N. 51-20 E. 445 feet to an iron pin and said access road, the point of beginning.
