"ALL that of riain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, lying and being on the southeast side of the Putman Road and being known and designated as lot #11/on the property of John K. Keller, shown on a plat thereof by W. J. Riddle, surveyor, dated a re-subdivision of the greater part of Lots No. 23 and 24 of Farr Estates as shown by a plat there of recorded by Batton and Neves Engineers dated July 1941 and recorded in the R.M.C. office in Plat Book "M" at Page 19, and having thefollowing metes and bound to wit.
