"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Fairview Township, located on South Carolina Highway No. 2, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northerly side of said highway and running thence N. 1-100 W., 153.9 feet; thence S. 61-15 W. 347 feet to an iron pin 17 feet from the center line of railway: thence S. 19-15 E., 138 feet thence N. 61-15 E., 300 feet to the beginning corner, and being the same lot of land conveyed to mortgagors by William D. Hopkins by deed recorded in the Greenville County R. M. C. Office in Book 885 at page 592.
