All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township, being known and designated as Lot No. 6 of Greenfields as shown on plat thereof recorded in the RMC Office for Greenville County in plat book XX at page 103 and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the eastern side of Mitchell Road, at the joint front corner of Lots 5 and 6 and running thence along the line of lot 5, N. 78-57 E. 170.6 feet to an iron pin in the line of lot 12; thence along the line of lot 12, S. 7-06 E. 100.0 feet to an iron pin at the joint rear corner of Lots 6 and 7; thence along the line of lot 7, S. 78-50 W. 166.3 feet to an iron pin on the eastern side of Mitchell Road; thence along Mitchell Road N. 10-13 W. 100.0 feet to the beginning corner.
