"ALL that certain place, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, lying on the East side of the Buncombe Road, about 2½ miles northwest from the City of Greer, being all of Lots No's 26, 27, 28, 29 and 30 on a plat of property made for C.L. King by S.C. Moon, Surveyor, dated April, 1941, which plat is on record in the R.M.C. Office for Greenville County in Plat Book L, at page 187, said lots fronting 278 feet on the East side of the said Buncombe Road, bounded on the north by the W.W. Burgiss Estate, by Kelley on the South, on the East by H.W. Couch, and on the West by Buncombe Road.
