"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northern side of Roberta Drive and being known and designated as Lot No. 6 of a subdivision known as Cherokee Forest, Plat No. 3, as shown on a plat thereof being recorded in the RMC Office for Greenville County in Plat Book QQ at pages 36 and 37, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Roberta Drive, joint front corner of Lot Nos. 6 and 7, and running thence with the joint line of said lots, N. 10-31 E. 271. 9 feet to an iron pm; thence N. 85-29 W. 100.55 feet to an iron pin, joint rear corner of Lot Nos. 5 and 6; thence with the joint line of said lots, S. 10-31 W. 261.4 feet to an iron pin on the northern side of Roberta Drive; thence with said Drive, S. 79-29 E. 100 feet to the point of beginning.
