"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southwesterly side of Vista Drive, near the City of Greenville, S. C. in Plat Book MM, at page 153 and having according to said plat, the following metes and bounds, to-wit:
