"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, on the north side of Alice Farr Drive, being shown as Lot No. 77 on plat of Sections 1 and 2 of Western Hills, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book QQ, Pages 98 and 99, and having, according to said plat, the following metes and bounds, to-wit:
