All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, being known and designated as Lot 2 according to plat of property of Jones E. Bowen prepared October 17, 1958 by Jones & Sutherland, Engineers, recorded in the R.M.C. Office for Greenville County in Plat Book at Page and having the following metes and bounds, to-wit:
