Samuel WHEREAS, in and by certain promissory note in writing of even date with these Presents, and truly indebted unto the Citizens Building and Loan Association, Greer, S. Hill, Manuel Samuel and in consideration of the said debt and sums of money aforesaid, and for the better securing the payment thereof to the said CITIZENS BUILDING AND LOAN ASSOCIATION, the said Charlie Hill, Annie May Greer, S. C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to the said mortgager in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND LOAN Association, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, on the northern side of a settlement road and having, according to a survey of property of Grace E. Greer prepared by Terry T. Dill dated July 18, 1957, the following metes and bounds to-wit:

Beginning at an iron pin in the center line of said settlement road at corner of property now or formerly belonging to Lillie McC.
