WHEREAS, we the said. Joe H. Couch and Thelma S. Couch in and by our certain promissory note in writing of even date with these Presents, are well and truly indebted unto the Citizens Building and Loan-Association, Greer, S. C., in the full and just sum of two thousand one hundred and no/100 - - - - (\$2,100.00) Dollars, with interest from the date hereof at the rate of eight per cent (| 8 %) per annum, unpaid interest to bear interest at the same rate, to be repaid in installments of

C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to us the said mortgagor. in hand well and truly paid by the said mortgage, at and before the scaling and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Citizens Building and Loan Association, Greer, S. Co., Greenville County," made by Dalton and Neves, Feb. 1950; Sections 3 and 4 of said plat are recorded in the R. M.
