All that certain piece, parcel or lot of land, with the improvements thereon, situate, lying and being near the Town of Fountain Inn, in Fairview Township, County of Greenville, State of South Cardlina, the same being shown on a plat prepared for Robbie S. Adams by Keels Engineering Company, dated December 14, 1970, to be recorded and having the following boundaries and measurements:
