All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Northwestern side of Delta Drive near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 86 as shown on a plat of Longforest Acres, Section 2 prepared by R. B. Bruce, dated July 3, 1969, and recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book 4F at page 11, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Northwestern side of Delta Drive at the joint front corner of Lots Nos. 85 and 86, and running thence with the line of Lot No. 85 N. 58-04 W. 143 feet to an iron pin; thence continuing N. 58-04 W. 10 feet, more or less, to a point in a branch; thence with the center line of said branch as the line (having a traverse line of S. 36-23 W. 114.7 feet) to a point at the joint rear corner of Lots Nos. 86 and 87; thence with the line of Lot No. 87 S. 57-54 E. 10 feet, more or less to an iron pin; thence continuing with the line of Lot No. 87 S. 57-54 E. 149.5 feet to an iron pin on the Northwestern side of Delta Drive; thence with the Northwestern side of Delta Drive N. 32-06 E. 115 feet to the point of beginning.
