14. That is the event this mortgage should be invacanced the Mortgager, expressly walves the benefits of Sections 45-86 through 45-90.1 of the 1902 Code of Laws of South Carolina, as presented or any other approximated laws.

THE-MORTCAGE COVENANTS AND ACRES AS FOLLOWS

- 1.
