NOW, KNOW ALL MEN, that Mortgagor (all, if more than one), to secure payment of a Promissory Note of even date from Mortgagor to Universal C.I.T. Credit Company (hereafter "Mortgagors") in the above Total of Payments and all future advances from Mortgagors to Mortgagor, the Maximum Outstanding at any given time not to exceed said amount stated above, hereby grants, bargains, sells, and releases to Mortgagee, its successors and assigns, the following described real estate together with all improvements thereon situated in South Carolina, County of GREENVILLE, ALL THOSE CERTAIN PIECES, PARCELS OR LOTS OF LAND ON THE SOUTHEASTERN SIDE OF MAYFAIR DRIVE, IN THE COUNTY OF GREENVILLE, STATE OF SOUTH CAROLINA, KNOWN AND DESIGNATED AS LOTS NOS. 15 AND 16 BLOCK C, MAYFAIR ESTATES, PLAT OF WHICH IS RECORDED IN THE R. M. C. OFFICE FOR GREENVILLE COUNTY, S. C. IN PLAT BOOK S, AT PAGES 72 AND 73, HAVING, ACCORDING TO SAID PLAT, THE FOLLOWING METES AND BOUNDS, TO-WIT:

BEGINNING AT AN IRON PIN ON THE SOUTHEASTERN SIDE OF MAYFAIR DRIVE AT THE JOINT FRONT CORNER OF LOTS NOS. 17 AND 16, AND RUNNING THENCE WITH THE JOINT LINE OF SAID LOTS, S. 60-48 E. 150 FEET TO AN IRON PIN; THENCE S. 29-12 W. 100 FEET TO AN IRON PIN AT THE JOINT REAR CORNER OF LOTS NOS. 15 AND 14; THENCE WITH THE JOINT LINE OF THOSE LOTS, N. 60-48 W. 150 FEET TO AN IRON PIN ON THE SOUTHEASTERN SIDE OF MAYFAIR DRIVE; THENCE ALONG SAID DRIVE, N. 29-12 E. 100 FEET TO THE POINT OF BEGINNING, BEING THE SAME PROPERTY CONVEYED TO THE GRANTOR HEREIN BY DEED OF WILLIAM CARTER LINK DATED SEPTEMBER 3, 1965, RECORDED IN THE R. M. C. OFFICE FOR GREENVILLE COUNTY IN DEED BOOK 781, PAGE 441.

TO HAVE AND TO HOLD all and singular the premises described above unto the said Mortgagors, its successors and assigns forever.

If the Mortgagor shall fully pay according to its terms the Indebtedness hereby secured then this mortgage shall become null and void.

Mortgagor agrees to pay all taxes, assessments and charges against the above-described premises.

Mortgagor also agrees to maintain insurance in such form and amount as may be satisfactory to the Mortgagors in Mortgagor's favor, and in default thereof Mortgagor may, but is not obligated to, effect said insurance in its own name.

Any amount which Mortgagor may expend to discharge any tax, lien, assessment, obligation, covenant, insurance premium, prior mortgage or any charge whatsoever in connection with the above described real estate shall be an additional lien secured by this mortgage with interest at the highest lawful rate if not prohibited by law, and may be enforced and collected in the same manner as the debt hereby secured.

All obligations of Mortgagor to Mortgagors shall become due, at the option of Mortgagors, without notice or demand, upon any default.

Mortgagor agrees in case of foreclosure of this mortgage to pay a reasonable attorney's fee as determined by the court in which suit is filed, and any court costs which shall be secured by this mortgage and included in judgment of foreclosure.

This mortgage shall extend, consolidate and renew any existing mortgage held by Mortgagors against Mortgagor on the above described real estate.
