Together with all and singular the rights members bereditionents and apperturances to the same belonging or a my way incident or appertaining and all of the posts of the same together and including all heating plumbing and lighting finteres and equipmen now or bereatter stacked to or used in connection with the real estate herein described.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgages, its successors and assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinshove described in fee simp solute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premise are free and clear of all liens and encumbrances whatsoever. The Mortgagor further covenants to warrant and for ever defend all and singular the premises unto the Mortgagos forever, from and against the Mortgagos and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor covenants and agrees as follows:

- 1. That he will promptly pay the principal of and interest on the indebtedness evidenced by the said note, at the times and in the manner therein provided. Privilege is reserved to pay the debt in whole, or in an amount equal to one or more monthly payments on the principal that are next due on the note, on the first day of any month prior to maturity; provided, however, that written notice of an intention to exercise such privilege is given at least thirty (30) days prior to prepayment; and, provided, further, that in the event the debt is paid in full prior to maturity and at that time it is insured under the provisions of the National Housing Act, he will pay to the Mortgagee an insurance premium charge of one per centum (1%) of the original principal smount thereof, except that in no event shall the adjusted premium exceed the aggregate amount of premium charges which would have been payable if the mortgage has continued to be insured until meturity; such payment to be applied by the Mortgages upon its obligation to the Secretary of Housing and Urban Development on account of mortgage insurance.

  - (a) An amount sufficient to provide the holder hereof with funds to pay the next mortgage insurance premium if this instrument and the note secured hereby are insured, or a monthly charge (in lieu of a mortgage insurence premium) if they are held by the Secretary of Housing and Urban Development, as follows:
    - (I) If and so long as said note of even date and this instrument are insured or are reinsured under the provisions of the National Housing Act; an amount sufficient to accumulate in the hands of the holder one (I) month prior to its due date the annual mortgage insurance premium to order to provide such holder with funds to pay such premium to the Secretary of Housing and Urban Development pursuant to the National Housing Act; as amended, and applicable Regulations thereunder; or
    - (II) If and so long as said note of even date and this instrument are held by the Secretary of Housing and Urban Development; a monthly charge (in lieu of a mortgage insurance premium) which shall be in an amount equal to onetwelfth (1/12) of one-half (1/1) per centum of the average outstanding balance due on the note computed without taking into account delinquencies or prepayments;
  - (b) A sum equal to the ground rents, if any, next due, plus the premiums that will next become due and payable on policies of fire and other hazard insurance covering the mortgaged property, plus taxes and assessments next due on the mortgaged property (all as estimated by the Mortgagee) less all sums already paid therefor divided by the number of months to elapse: before one (1) month prior to the date when such ground rents, premiums, taxes, and assessments will become delinquent, such sums to be held by Mortgages in trust to pay said ground rents, premiums, taxes, and special assessments; and
