"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, near the Town of Travelers Rest, being shown as Lot No. 2 on a plat of Section B, property of Seth W. Scruggs, dated April, 1969 by Webb Surveying & Map. Co. and recorded in the RMC Office for Greenville County in Plat Book 4-E at page 91 and being further described according to said plat, to wit:

BEGINNING at an iron pin on the western edge of Maple Lane, at the joint front corner with Lots Nos. 1 and 2 and running thence S. 85-37 W. 125 feet to an iron pin; thence S. 4-03 W. 83.4 feet to an iron pin; thence S. 86-45 E. 125 feet to an iron pin on the western edge of Maple Lane; thence with the western edge of said Lane, N. 3-15 E. 100 feet to an iron pin, being the point of beginning.

The Mortgagor covenents that it is lawfully selzed of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein.
