Township, located on the east side of Badger Drive, as shown on a survey entitled "Plat of lot of Alger Cannon" by Terry T. Dill, dated March 19, 1969, and being a portion of Lots Nos. 46 and 47 of the GROVELAND DELL SUBDIVISION, said lot having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the east side of Badger Drive, said iron pin being located 567 feet from the center line of Winesap Way, and running thence S. 87-22 B. 201.5 feet to an iron pin; thence S. 03-02 B. 110 feet to an iron pin; thence N. 87-22 W. 201.5 feet to an iron pin on the east side of Badger Drive; thence along and with Badger Drive, N. 03-02 W. 110 feet to the point of beginning.
