"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, being shown and designated as Lot 50 on plat of Pelham Estates recorded in the R.M.C. Office for Greenville County in Plat Book PPP at Pages 28 and 29, said property being located on the southwestern side of Cape Charles Drive and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the southwestern side of Cape Charles Drive, corner of Lot 49 and running thence with the southwestern side of Cape Charles Drive, N. 58-43 W. 200 feet to an iron pin at corner with Lot 51; thence with the line of said lot, S. 31-17 W. 218 feet to an iron pin in the line of Lot 52; thence with the line of Lots 52 and 53, S. 51-18 E. 201.7 feet to an iron pin at corner of Lot 49; thence with the line of said lot 49, N. 31-17 E. 244 feet to the point of beginning; being the same conveyed to us by Southeastern Insurance Services, Inc. by deed dated January 12, 1970 and recorded in the R.M.C. Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had thereform, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hercinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
