day of each and every month thereafter until paid in full with the right to anticipate
payment at any time without penalty with interest
from date at the rate of 6 1/2% per centum per annum
until paid; interest to be computed and paid monthly and if unpaid when due to
bear interest at same rate as principal until paid, and the mortgagor(s) has (have)
further promised and agreed to pay ten per cent of the whole amount due for attor-
ney's fee, if said note be collected by attorney or through legal proceedings of any
kind, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That the said mortgagor(s) in consideration of the said
debt and sum of money aforesaid, and for the better securing the payment thereof,
according to the terms of the said note, and also in consideration of the further sum
of Three Dollars, to the mortgagor(s) in hand well and truly paid at and before the
sealing and delivery of these presents, the receipt whereof is hereby acknowledged,
have granted, bargained, sold and released, and by these presents do grant, bargain,
sell and release unto the said mortgagee(s) the following described real property:

ALL that piece, parcel or tract of land near Paris Mountain (on the western side of
White Horse Road) in Greenville County, South Carolina and being the western portion
of a 51 1/2 acre tract of property known as Tract 3 of property of the Green Estate and
being shown as property of Carolina Real Estate Co., Inc. on a plat prepared by Dan
E. Collins, Surveyor No, 1760, said plat being recorded in the R. M. C. Office for
Greenville County in Plat Book TT at page 167. The property herein conveyed in-
cludes all the property lying west of the center line of White Horse Road received
by the Grantors in Deed recorded in the R. M. C. Office for Greenville County in
Deed Book 642 at page 81 and as is shown on the plat referred to above. According
to said plat, the property has the following metes and bounds, to-wit:

BEGINNING at an iron pin in the center of White Horse Road and running thence N. 79-
30 W. 135 feet, more or less, to an iron pin; thence running N. 30-30 W. 867 feet to
a stone; thence running S. 79-45 E. 915 feet, more or less, to the center of White
Horse Road; thence with the center of White Horse Road in a southerly direction 630
feet; more or less, to the point of beginning.
