All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as the larger portions of Lots 170 and 171, Section III, of Westcliffe Subdivision, as shown on a plat prepared by Piedmont Engineers & Architects, dated December 11, 1963, and revised on September 24, 1965, and recorded in the R. M. C. Office for Greenville County in Plat Book JJJ at Pages 72, 73, 74 and 75, said combined lots now being designated as Lots 170 and 171 on a revised plat prepared by Jones Engineering Service, dated July 10, 1970, recorded in the R. M. C. Office for Greenville County in Plat Book 4-E at page 113, and according to said revised plat, having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Westcliffe Way at the joint front corner of Lots 171 and 172 according to the the most recent plat and running thence N. 23-23 W. 228 feet to an iron pin; thence running N. 5-10 E. 120.4 feet to an iron pin; thence running S. 70-17 E. 123.7 feet to an iron pin; thence running S. 24-43 E. 248.5 feet to an iron pin on the northern side of Westcliffe Way; thence with Westcliffe Way S. 65-17 W. 105 feet to an iron pin; thence continuing with Westcliffe Way S. 67-17 W. 50.3 feet to an iron pin, the point of beginning.
