All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the north side of Lee Haven Court, being known and designated as Lot 30 on Plat of Barbrey Heights, Section 2, which plat is recorded in the R.M.C. Office for Greenville, S. C. in Plat Book BBB, Page 175, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of Lee Haven Court at the joint corner of Lots 29 and 30 and runs thence along the line of Lot 29 N. 28-49 W. 305 feet to an iron pin; thence S. 69-00 E. 198 feet to an iron pin; thence along the line of Lot 31 S. 19-55 E. 220 feet to an iron pin on the north side of Lee Haven Court; thence along Lee Haven Court S. 70-05 W. 35 feet to an iron pin; thence with the curve of Lee Haven Court (the chord being S. 89-11 W. 35 feet) to an iron pin; thence continuing with the curve of Lee Haven Court (the chord being N. 62-40 W. 50 feet) to the beginning corner.
