All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville on the Western side of Oakview Drive and being known as Lot No. 13 on a plat entitled "Sunset Circle" prepared by T. C. Adams, Engineer, dated November, 1955, and recorded in the RMC Office for Greenville County in Plat Book JJ at page 103 and being more fully described as follows:

BEGINNING at an iron pin on the West side of Oakview Drive at the joint front corner of Lots 12 and 13 and running thence with the line of Lot 12,N. 81-02 W. 99 feet to an iron pin; thence N. 11-58 E. 174 feet to an iron pin; thence S. 37-48 E. 95.3 feet to an iron pin on the West side of Oakview Drive; thence with the curve of Oakview Drive (the chord being S. 2-45 W. 67.9 feet) to an iron pin; thence continuing with Oakview Drive S. 8-47 E. 25 feet to an iron pin; thence still with Oakview Drive S. 7-56 E. 18.2 feet to the point of beginning.
