"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

ALL that certain piece, parcel, or lot of land with all improvements thereon, situate, lying and being in the state of South Carolina, County of Greenville, located on the northwestern side of Bradley Boulevard in the City of Greenville, and being designated as Lot No. 84 on the plat of University Park, as recorded in the R.M.C. Office for Greenville County in Plat Book "P", page 127, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Bradley Boulevard, joint front corner of Lots 83 and 84, and running thence with the common line of said lots, N. 37-34 W. 197.7 feet to an iron pin on the southerly side of Brookside Circle; thence with the southerly side of said Circle, S. 57-38 W. 75.3 feet to an iron pin, the joint corner of Lots 84 and 85; thence along the common line of said lots, S. 37-34 E. 204.7 feet to an iron pin on the northwestern side of Bradley Boulevard; thence with Bradley Boulevard N. 52-26 E. 75 feet to the beginning corner.
