"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, containing .81 acres, and having, according to a survey prepared by Carolina Engineering and Surveying Company August 6, 1971, and recorded in the R.M.C. Office for Greenville County in Plat Book 4-K at Page 199, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeasterly side of Thompson Street at a point in the center of a creek and in line of property this day conveyed to Davidson and running thence with Thompson Street N. 51-05 W. 196.6 feet to an iron pin; thence N. 41-27 E. 99.9 feet to an iron pin; thence N. 40-32 E. 102.4 feet to an iron pin; thence S. 39-54 E. 194 feet to a point in the center of the creek; thence with the center of said creek S. 39-16 W. 164.5 feet to the point of beginning.
