ALL that certain piece, parcel or lot of land in the County of Greenville, State of South Carolina, on the east side of Oak Park Drive and being known and designated as a portion of Lot 41 and a portion of Lot 40 on Plat of Parkwood, Section 1, which plat was made by C. O. Riddle, Surveyor, July 27, 1969, and recorded in the R.M.C. Office for Greenville, S. C. in Plat Book 4-F, Page 22, and having, according to a more recent plat entitled "Revised Plat of Lots 40; 41 and 42, Parkwood, made by C. O. Riddle, Surveyor, August 10, 1971, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the east side of Oak Park Drive at the joint corner of Lots 41 and 42 and runs thence along a new line through Lot 41 N. 81-41 E. 148.9 feet to an iron pin; thence S. 12-28 E. 27.4 feet to an iron pin; thence S. 75-03 E. 40 feet to an iron pin; thence along a new line through Lot 40 S. 60-05 W. 160 feet to an iron pin on the east side of Oak Park Drive; thence with the curve of Oak Park Drive (the chord being N. 35-52 W. 55 feet) to an iron pin; thence continuing with the curve of Oak Park Drive (the chord being N. 22-29 W. 55 feet) to the beginning corner.
