"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot 42 on plat of 'Whispering Pines Subdivision - North of Piedmont, S. C." prepared by F. E. Ragsdale, S. C. Reg. Land Surveyor, dated April 1, 1962, revised August 1962, having the following metes and bounds:

Beginning at an iron pin on Oak Hill Drive at the joint corner of Lots 42 and 43, and running thence with lines of Lots 43, 44, and 45, S 30-00 W 229.1 feet to an iron pin at joint rear corner of Lot 45; thence with line of property now or formerly of Ben F.
