"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Butler Township, as shown on a plat and survey made by Pickell and Pickell, dated April 4, 1945, containing 2 acres, more of less, and having, according to said plat the following metes and bounds, to wit:
