NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, being more specifically shown as one of two lots of the property on the plat of Property of Joe M. Busby by John C. Smith, Surveyor, dated June 11, 1971 and recorded in Plat Book 4K at page 75 and according to said plat having the following metes and bounds, to-wit:

BEGINNING AT an iron pin on the south side of Hellene Street at the joint front corner of another lot, belonging to the Grantor, shown on plat, said point being 290.5 feet in a northeasterly direction from the intersection of Emile Avenue and Hellene Street; and running thence along Hellene Street N 60-28 E 289.1 feet to an iron pin on the south side of Hellene Street; thence turning and running S 24-57 E 312.4 feet to an iron pin; thence S 60-52 W 133.4 feet to an iron pin; thence S 60-05 W 133.2 feet to an iron pin at the joint rear corner of the other lot, belonging to Grantor. Thence N 24-57 W 312.4 feet to the beginning point. Said lot containing 1.90 acres.
