in and by Our certain promissory note in writing, of even date with these presents, am (are) well and truly indebted to Piedmont Construction Company in the full and just sum of Sixteen Hundred Seventy and 40/100 - - - - - - - Dollars,

(\$1,670.40) payable thirty-four and 80/100 (34.80) Dollars on January 4, 1972 and thirty-four and 80/100 (34.80) Dollars on the 4th. of each and every month thereafter until the entire amount is paid in full.

, with interest thereon from maturity at the rate of eightper cent, per annum, to be computed and paid semi-annually until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder thereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of ten per cent, besides all costs and expenses of collection, to be added to the amount due on said note and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, will more fully appear.

, in hand and truly paid by the said Piedmont Construction Company at and before the signing of these Presents, the receipts whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Piedmont Construction Company, its heirs and assigns, FOREVER:

ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, in Chick Springs Township, lying two or three chains north of Mountain Creek and being more fully described as follows:

BEGINNING at an iron pin and running thence N 81½ W 3.21 chains; thence S 15 W 156 chains; thence S 81½ E 3.21 chains; thence N 15 E 156 chains to the point of beginning and containing ½ acre, more or less.
