MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

I. Hugh B. Poston, of Greenville County
(hereinafter referred to as Mortgagor) (SEND(S) GREETING
WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OGREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of
Twenty Thousand, Two Hundred and No/100
Dollars, as evidenced by Mortgagor's promissory note of even date herewith, which note does not contain a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain
conditions), said note to be repaid with interest as the rate or rates therein specified in installments of

WHEREAS said note further provides that if at any time any parties of the principal or interest due thereunder shall be not

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagoe for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further—sums which may be advanced by the Mortgagee to the Mortgagor's, account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Tract No. 1 on a plat of Property of Alvin and Ruth Ann Hester prepared by Jones Engineering Services on May 25, 1971, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of North Parker Road, joint front corner of property of David Lassiter; running thence with Lassiter line, S. 79-08 E. 217.9 feet to an iron pin; thence S. 21-30 W. 300 feet to an iron pin; thence N. 57-31 W. 254.8 feet to an iron pin on the southeastern side of North Parker Road; thence with said road, N. 39-41 E. 50 feet to an iron pin; thence with said road, N. 28-35 E. 165 feet to the beginning corner; being the same conveyed to me by Alvin Hester by deed dated August 31, 1971, and recorded in the R. M. C. Office for Greenville County in Deed Vol. 924 at Page 141.
