MODIFICATION AGREEMENT

WHEREAS, on the 14th day of July 19 71, First Federal Savings and Loan Association of Greenville, S. C. made a mortgage loan to M. L. Pape and Judith A. Pape to make payments on the aforesaid mortgage being recorded in the R. M. C. office for Greenville County in Mortgage Book 198, at page 403 at the rate of \$158.89 per month, bearing interest at the rate of $7\frac{1}{2}$ % per annum, payable monthly, and that so long as said payments are made promptly on the first day of each and every calendar month this loan shall not be considered delinquent, but should the mortgagor fail to make said payments as agreed, then, in that event, the holder of this mortgage may institute foreclosure proceedings without further delay according to the terms as set out in said note and mortgage.

IT IS EXPRESSLY UNDERSTOOD AND AGREED that no other terms of the aforesaid note and mortgage are in any way changed, altered, or amended by this agreement.
